

**AGREEMENT ON ACADEMIC EXCHANGE  
BETWEEN  
FACULTY OF ENGINEERING, KYRGYZ-TURKISH MANAS UNIVERSITY, KYRGYZSTAN  
AND  
FACULTY OF SCIENCE AND ENGINEERING, IWATE UNIVERSITY, JAPAN**

The Faculty of Engineering, Kyrgyz-Turkish Manas University and the Faculty of Science and Engineering, Iwate University hereby enter into this AGREEMENT ON ACADEMIC EXCHANGE ("Agreement") in order to promote cooperative relations and academic exchanges between the two universities as follows:

1. Each university shall make an effort to implement and develop the following matters:
  - (1) Exchange of faculty members and research staff
  - (2) Exchange of undergraduate and graduate students
  - (3) Exchange of academic materials and publications
  - (4) Conducting joint research projects and organizing symposia
2. The two universities shall consult on the specific implementation of each matter of the preceding paragraph before commencing the matter, and obtain consent in writing.
3. This Agreement is valid for five years from the date of signing by both universities. The term of validity of this Agreement may be extended by mutual agreement of both universities. Even within the term of validity of this Agreement, each university may, by giving six months' advance written notice to the other university, terminate this Agreement.
4. This Agreement is executed in duplicate in English. Each university will keep one of the duplicates.




17. The exchange student dispatched by each university shall be subject to the Host University's rules related to intellectual property rights. The universities shall keep in confidence and not disclose to any third party the research activities of exchange students and the results, unless supervising instructors of both universities decide to disclose them.
18. Both universities shall respect each other's rights concerning confidentiality and intellectual property, and shall make decisions concerning intellectual property rights resulting from exchange of students through consultation between both universities.
19. In the case of a problem occurring when implementing this MOA on the exchange of students, or an unpredictable urgent event occurring while carrying out programs prescribed in this MOA, both universities shall promptly handle the problem according to the laws of the country or state in which the Host University is located, or in accordance with international custom in order to improve and/or resolve the situation.
20. This MOA may be terminated by the written notice of either university given six (6) months prior to the date of termination.
21. This MOA shall be prepared in English in duplicate, one copy of each text to be held by the Faculty of Science and Engineering at Iwate University and the Faculty of Engineering at Kyrgyz-Turkish Manas University.

MEMORANDUM OF AGREEMENT FOR STUDENT EXCHANGE  
BETWEEN  
FACULTY OF ENGINEERING, KYRGYZ-TURKISH MANAS UNIVERSITY, KYRGYZSTAN  
AND  
FACULTY OF SCIENCE AND ENGINEERING, IWATE UNIVERSITY, JAPAN

The Faculty of Engineering at Kyrgyz-Turkish Manas University, KYRGYZSTAN, and the Faculty of Science and Engineering at Iwate University, JAPAN, hereby enter into an academic agreement for the exchange of undergraduate and graduate students founded on the principles of reciprocity and mutual benefit, based on Agreement on Academic Exchange between the Faculty of Engineering at Kyrgyz-Turkish Manas University, KYRGYZSTAN and the Faculty of Science and Engineering at Iwate University, JAPAN. The Faculty of Science and Engineering at Iwate University, JAPAN and the Faculty of Engineering at Kyrgyz-Turkish Manas University, KYRGYZSTAN, agree to the following:

1. Students shall be enrolled in either the Faculty of Engineering at Kyrgyz-Turkish Manas University or the Faculty of Science and Engineering at Iwate University. For the purpose of this MOA, the university in which they are enrolled is referred to as the "Home University", and the university where their exchange takes place is referred to as the "Host University". The Home University shall be responsible for screening and selecting students in accordance with the Host University's requirements, including language proficiency requirements. The final decision as to whether or not to accept a student nominated by the Home University shall be carried out by the Host University.
2. The number of students accepted by both universities is two (2) or less each year at each university. The number of students accepted may be amended by mutual agreement. Both universities shall make efforts to ensure equilibrium throughout the term of this MOA.
3. The exchange students' period of enrollment at the Host University shall not exceed one (1) year.
4. Exchange students shall pay the tuition fee for the exchange period to the Home University, and shall pay student activity expenses, examination fees, and course-related expenses to the Host University. All personal expenses, including visa acquisition expenses, round-trip travel expenses to the Host University, accommodation expenses, living expenses, expenses of textbooks and other educational materials, and various insurance costs (medical insurance, health insurance, etc.) shall be borne by the student.
5. Each university shall provide the other university and its students with the necessary information to affect the exchange (deadlines, required documents, housing information, insurance requirements, etc.).
6. Each university shall secure exchange students with housing that is owned or contracted by the university. It is the students' responsibility to apply for housing by the applicable deadlines.

7. Exchange students shall be required to have health insurance that meets the requirements stipulated by the Home University and Host University, and the government for the period of the exchange.
8. Exchange students shall have the same rights and benefits as the Host University's students and shall be subject to the Host University's academic rules and student code of conduct. Exchange students shall be also subject to the regulations and laws of the country in which the Host University is located.
9. Iwate University's students enrolled at Kyrgyz-Turkish Manas University shall be treated as "exchange students" in accordance with Kyrgyz-Turkish Manas University's regulations. Kyrgyz-Turkish Manas University's students enrolled at Iwate University shall be treated as "exchange students" in accordance with Iwate University's regulations. Exchange students shall be permitted to enroll at the Host University in any course, subject to admission requirements, pre-requisites, and course schedule and capacity constraints.
10. Credits earned by the exchange student at the Host University shall be recognized by the Home University in accordance with the Home University's regulations. Whether or not the Host University's subjects apply to the degree acquisition requirements shall be instructed by the Home University at its own risk.
11. The Host University shall issue documents necessary for student visa acquisition by prospective exchange students. Each exchange student shall be responsible for obtaining his or her own visa and for complying with immigration regulations.
12. The Home University shall ensure that the exchange students have sufficient language ability to successfully complete coursework in the Host University's faculty.
13. The Home University shall ensure that the exchange students are eligible to achieve their goals for studying under the conditions presented by the Host University. In the case of other problems arise, the Home University shall take appropriate measures at its own responsibility.
14. The Host University shall be responsible for maintaining the acceptance conditions presented and for providing the same support as the Host University giving to international students in general so that students can fulfill the purpose of study abroad.
15. The exchange student dispatched by each university shall not give personal or property damage to the Host University.
16. Each university shall participate in comprehensive general liability insurance that provides coverage for human and property damage caused by exchange students dispatched by each university.
