

# MEMORANDUM OF UNDERSTANDING BETWEEN FACULTY OF EDUCATION, WAYMADE COLLEGE OF EDUCATION, CVM UNIVERSITY



(GUJARAT, REPUBLIC OF INDIA)
AND

FACULTY OF LETTERS, KYRGYZ-TURKISH MANAS UNIVERSITY (BISHKEK, KYRGYZSTAN)

### 1. Parties

The parties to this MOU are

- 1.1 Faculty of Education, Waymade College of Education, CVM University, Vallabh Vidyanagar, Gujarat. India., hereafter referred to as "WMCE"
- 1.2 Faculty of Letters, Kyrgyz-Turkish Manas University, Bishkek, Kyrgyzstan, hereafter referred to as "KTMU"

## 2. Purpose

- 2.2 The broad objectives of this MOU are to promote cultural, educational exchange, collaboration and technical interchange between the parties involved as educational partners.
- 2.3 Upon the mutual consent of the parties, including the relevant academic management units within the universities, and subject to the availability of funds, collaboration may be carried out in, but not necessarily limited to, any of the following activities:
  - 2.3.1 Collaborative research and publication
  - 2.3.2 Visits between universities by academic, technical and administrative staff.
  - 2.3.3 exchanges of faculty and administrative staff
  - 2.3.4 exchanges of students
  - 2.3.5 Student articulation of courses at the two universities
  - 2.3.6 Sharing of academic materials
  - 2.3.7 Conduct various training programs
  - 2.3.8 Joint organisation of conferences, seminars or other academic meetings.
  - 2.3.9 Joint organisation of special technical or administrative programs.
  - 2.3.10 Joint production and delivery of courses and programs.
  - 2.3.11 exchanges of research materials, publications, reports, and other academic information
  - 2.3.12 organizing of joint research projects/research(s)
  - 2.3.13 assisting in teaching courses, teaching and learning, preparing TLMs
  - 2.3.14 any other academic activities of mutual benefit to both students and faculty of both university departments/ the universities

- 2.4 The implementation of exchanges based on this agreement will be separately negotiated, determined and accepted by both universities.
- 2.5 Addenda to this document identify specific projects, which will be undertaken within this overall MOU, and the details of their management. Further addenda may be developed at any time, but require the signatures of both Chief Executive Officers in order to be implemented as part of this MOU.
- 2.6 Whilst the purpose of this MOU is to outline an academic and management framework between the two parties, designed to promote internationalisation in both institutions, the parties do not intend to be legally bound to each other, and this MOU does not impose legal obligations on either party.

## 3. Joint Managers, Administrative Officers and Working Parties

- 3.2 The CEO of each party to this MOU will each appoint one person to act as the Joint Managers of this MOU.
- 3.3 The Joint Managers may appoint Administrative Officers or Working Parties to manage the details of particular activities or programs, as specified in the addenda to this MOU.

## 4. Publicity and Advertising

- 4.1 The parties agree that each may publish or advertise the existence and nature of activity under this MOU, provided that the partner does not indicate in writing that a specific matter should remain confidential.
- 4.2 All marketing or publicity material produced by WMCE, which refers to KTMU, will be submitted to the Joint Manager at KTMU, for approval before public distribution.
- 4.3 All marketing or publicity material produced by KTMU, which refers to WMCE, will be submitted to the Joint Manager at WMCE for approval before public distribution.

#### 5. Duration of MOU

- 5.2 This agreement will come into effect when signed by the representatives of WMCE and KTMU and will have duration of three (3) years, when it will be reviewed for possible renewal for another five-year period. Extensions and/or modifications may be made as agreed to by both parties.
- 5.3 Any of the party may cancel this agreement by providing the other with a written notice prior to three (3) months. Both the partners shall be free to take up the activities on their own as per their choice and it would be not a binding for any of the partners to ask each other.
- 5.4 The Joint Managers may, by mutual agreement at any time, and subject to written ratification by the Chief Executive Officers, modify the activities or arrangements undertaken under this MOU.

- 5.5 Either party may, on three-month notice in writing, terminate the MOU in advance of its normal expiration or request the renegotiation of its conditions. Under such circumstances, staff or students should be allowed to complete the activity under old conditions who have commenced an activity under the MOU.
- 5.6 Neither institution shall be held responsible for non-fulfilment of their respective obligations under this agreement due to exigencies of one or more of the 'force majeure' events such as but not limited to acts like floods, earthquake, strike, lock-outs, epidemics, pandemics, riots, wars and commotions, etc.., provided on the occurrence and cessation or cessation of such events, the party within one month of such occurrence or cessation informs the other party. If the 'force majeure' conditions continue beyond six months, the parties shall then mutually decide about the future course of actions.
- 5.7 Addenda to this document are an indispensable part of this MOU. The MOU is made in English only.
