



MEMORANDUM OF

COOPERATION

between

"Sh. Yessenov Caspian University of Technology and Engineering" NP JSC

(Yessenov University)

(Republic of Kazakhstan)

and

Kyrgyz-Turkish Manas University

(Kyrgyz Republic)

«14» December 2023

"Sh. Yessenov Caspian University of Technology and Engineering" non-profit joint-stock company, represented by President-rector Berik Bakytzhanovich Akhmetov, on the one part, and "Kyrgyz-Turkish Manas University", represented by Rector Alpaslan CEYLAN, on the other part (hereinafter jointly referred to as the Parties, and individually as the Party),

In view of the partnership and close international relations between the Republic of Kazakhstan and Kyrgyz Republic

recognizing the need to develop further bilateral relations between two countries in the educational and scientific areas of cooperation,

desiring to make contribution to the development of cooperation between two educational institutions in the abovementioned areas,

have entered into this Memorandum of Cooperation (hereinafter - Memorandum) on the following conditions.

Article 1

According to principles of mutual benefit and respect for independence, the Parties will stimulate: 1.Exchange of university staff and faculty members;

2.Exchange of bachelors, master's degree, PhD students for the purpose of completion of research practice and internship;

3.Development and implementation of joint educational programs, including those awarding double degree, as well as course study programs;

4. Arrangement of academic meetings and symposiums;

5. Scientific exchange of scientists, specialists and students;

6. Undertaking of scientific internships by students and teaching staff;

7. Implementation of joint research programs, projects for the creation and development of technologies;

8. Involvement of university scientists as consultants for master's and doctoral dissertations;

9. Formation of joint temporary research teams, laboratories that ensure the development of new equipment and technologies;

10. Involvement of university scientists to carry out scientific work in research institutions;

11. Exchange of scientific and technical information, documentation, literature and bibliographic outputs, product samples;

12. Conducting joint seminars, scientific conferences, working meetings;

13. Joint preparation of the results of the work for publication in the open press;

14. Joint preparation of documents for participation in applications for obtaining financing, as well as in other mutually agreed forms that ensure the implementation of this agreement.

Article 2

The conditions for the implementation of each program of cooperation under the Memorandum should be agreed upon and adopted by both universities through conclusion of individual agreements before implementation of each individual program. These individual agreements will clearly describe the functions and activities to be carried out, work schedule, personal profiles, financing conditions, the rights and obligations of each Party, as well as the documents necessary to define the purpose and areas of cooperation within each program.

Article 3

It is understood that all activities under the Memorandum are approved by respective executives in each university and meet the scientific and financial requirements of both universities. The results of joint research, including but not limited to resulting intellectual property rights, should be used in good faith, through consultations between the Parties.

<u>Article 4</u>

In the process of implementation of the Memorandum, the Parties shall be governed by the legislation of their country, and also undertake to observe interstate agreements on cooperation in the field of education, science and culture between the Republic of Kazakhstan and Kyrgyz Republic.

All types of cooperation specified in Article 1 must be implemented in accordance with all laws and regulations of the country in which these types of cooperation will be implemented.

Article 5

This Memorandum shall enter into force from the date of last signing by authorized representatives of both universities and shall remain in force until terminated by either Party by notifying the second Party. Notice of termination of the Memorandum must be provided at least six months before the expected date of termination. Regardless of the termination of the Memorandum, the Parties must continue to fulfill their obligations until all participants who have started training under the exchange program complete their studies. The Memorandum may change at any time by mutual agreement of the Parties.

This Memorandum is made in two copies in English, each having equal legal force, one for each Party.
